 other gun control advocates
 lobbied for over 7 years
 - James Brady was permanently disabled by gunman who attempted to kill Ronald Reagan in 1981
- Growing public support and Bill Clinton helped pass what we know today as the Brady Handgun Violence Prevention Act
 - Signed into law in 1993





Brady Bill

Prospective firearm buyers are required to have a background completed.

During which time the sale is approved or prohibited based on an established set of State and Federal Statutes.





Law requires federally licensed firearms dealers to initiate a background check on the purchaser prior to sale of a firearm

UCA 76-10-503 (9)(B)

A person may not provide to a dealer or other person any information that the person knows to be materially false information with intent to deceive the dealer or other person about the legality of a sale, transfer or other disposition of a firearm or dangerous weapon

- (c) "Materially false information" means information that portrays an illegal transaction as legal or a legal transaction as illegal
 - (d) A person who violates this Subsection (9) is guilty of:
 - (i) A third degree felony if the transaction involved a firearm

UCA 76-10-503 (2)

A Category I restricted person who intentionally or knowingly agrees, consents, offers, or arranges to purchase, transfer, possess, use...

(a) Any firearm is guilty of a second degree felony



Evidence

- > Copy of the signed 4473
- > Video of transaction
 - Obtain copy ASAP
- > BCI Brady denial packet

- > Court records
 - Certified copies of convictions
- > Interviews
 - Clerk that sold firearm
 - Subject that attempted purchase

Considerations

- Utilize victim advocates
 - Notification to victim on open cases
- Pawn shop purchases/ buying their gun back
 - Felon in possession

- Straw purchases
- > Jurisdiction
 - Location of Crime vs.
 Residence of Restricted Person
- > Educating prosecution
