## "PACKING" WARRANTS



The State of Utah Bureau of Criminal Identification will audit every agency in the state of Utah, who has access to UCJIS and/or UCJIS information, at least once during a 3 year FBI audit cycle



One area of the FBI audits focuses on are warrants in the system and if they are updated with the most up to date information

\*Warrant #111111 should have an Driver License number listed. There was a skeleton record associated with Mr. Bear that contained the license number 11111111. Additionally, Mr. Bear has a Utah Criminal History associated with him. The SID # is 1111111. Here you can pull additional information to add to the warrant.

\*Warrant #2222222, is not a compliance issue. Address on warrant does not match any on file with Drivers License, but does match address used on Utah Criminal History. Just a reminder to always try to use more current address.

\*Warrant #333333 Drivers License has his middle name listed for this individual. Include that in the subjects full name on warrant: Bart Matthew Simpson. Also, Drivers License spells his last name as Simpson and it is listed as Simpsen on the Warrant. This is just a reminder to double check all spelling on warrant. Also, the Utah Criminal Histroy has an alias of El Barto Simpson. This should also be listed on warrant.



Updating and packing warrants should take place annually, but if able monthly, quarterly, or bi-annually is preferred.



Verify that the warrant is still valid and/or has basic identifying information to be listed

- No longer valid = remove
- No DOB = remove





### Is the information correct?

- Correct charges

- Any additional information that can be entered
- Anything that will increase the likelihood of a positive hit







## **FELONY WARRANTS**



The bureau shall submit a record received pursuant to Section 53-10-208. I for all nonextraditable warrants issued for violent felonies as defined in UCA 76-3(203.5) and all nonextraditable warrants issued for knowingly failing to register for a sexual offense pursuant to UCA 77(41)(107) to the National Crime Information Center (NCIC) within 48 hours of receipt, excluding Saturdays, Sundays, and legal holidays

UCA 53-10(214)



Courts will enter felony warrants into their database or WMS to issue a SWW

Batch job will pick it up and send it to NCIC

 NCIC Entry will then be made and a broadcast message sent to the LE agency who will own the NIC The batch job will not pick up a warrant with missing required identifiers

Each court will receive an email notifying them of the warrant numbers that were not pushed on to NCIC with the reason why

 The court will need to get that information to pack the SWW so that it will get added to NCIC

## Court Responsibilities

- Pack the record using all available
   UCJIS files your agency can access
- Use reports and information from LE
  - Case reports
  - Citations



<sup>\*</sup>This is a compliance issue on your audit as well as your responsibility with felony warrants\*



When entering the state wide warrant, make sure you put the correct originating agency

Some cases belong under a Probation office, correctional facility, etc.



Do not put your own ORI into the originating agency field



When you recall a warrant in WMS or CORIS, the agency who owns the NCIC entry for that SWW that you issued will receive this notification letting them know to remove it from NCIC

## Expiring a SWW

- If you modify an expiration date on a SWW instead of recalling it, you MUST notify the agency you have designated as the originating agency
- When the batch job is done by BCI to push those SWW onto SWW and NCIC, it will actually remove the NCIC entry
- The originating agency needs to know so they can close the case within their departments files






