

WHAT'S IN A PROTECTIVE ORDER?

How a JRA is entered, modified and removed from the Utah system and NCIC. It will also cover some issues agencies have with the transactions of ENCO, MCNO and MCJR.



UCA 78B-7-801

- (1) "Jail release agreement" means a written agreement that is entered into by an arrested individual, regardless of whether the individual is booked into jail:
 - (a) under which the arrested individual agrees to not engage in any of the following:
 - (i) have personal contact with the alleged victim;
 - (ii) threaten or harass the alleged victim; or
 - (iii) knowingly enter on the premises of the alleged victim's residence or on premises temporarily occupied by the alleged victim; and
 - (b) that specifies other conditions of release from jail or arrest.
- (2) "Jail release court order" means a written court order that:
 - (a) orders an arrested individual not to engage in any of the following:
 - (i) have personal contact with the alleged victim;
 - (ii) threaten or harass the alleged victim; or
 - (iii) knowingly enter on the premises of the alleged victim's residence or on premises temporarily occupied by the alleged victim; and
 - (b) specifies other conditions of release from jail.

(5) "Qualifying offense" means:

- (a) domestic violence;
- (b) an offense against a child or vulnerable adult; or
- (c) the commission or attempted commission of an offense described in Title 76, Chapter 5, Part 4, Sexual Offenses.

ADDING PO'S AND JRA'S TO NCIC

- BCI runs a batch job that grabs that JRA and pushes it onto NCIC
- Courts issue Protective orders through their CORIS program
- BCI runs a batch job that pulls them over to our server where they will be quarriable on NCIC and the Utah PO system
 - That batch job also pulls any modifications, cancellations, etc. done through their program for the PO for the Utah system
 - Same batch job automatically pushes them on to NCIC, updates the expiration date or status on NCIC

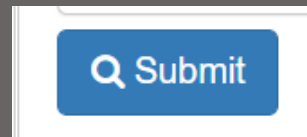

JRA EXPIRATION

- State Statute gives the JRA an automatic 30 day expiration date
- If the defendant appears and you mark them as present in CORIS, it will expire the JRA as of that day
- If the Judge wants the JRA to remain until the next court date and you change the expiration date in UCJIS, you will not mark the defendant as present. Doing so will expire JRA regardless of expiration date in UCJIS.
- You can also go into the Jail Release Agreement screen in CORIS, enter OTN or name to search, select Expire if the JRA is no longer needed

JRA EXPIRATION

The jail release agreement or jail release court order *expires at midnight* :

- On the day on which the person arrested **appears in person or by video** for arraignment or initial appearance
 - exception: Unless extended by Judge and the court

PO RETENTION PERIOD





NCIC RETENTION PERIOD

1. A POF record (EPO or ETO) will remain active until it is canceled or cleared by the entering agency or until the order expires. Five days prior to an order's expiration date, an unsolicited \$.P. administrative message will be sent to the ORI of record. This message will serve to notify the agency of the order's impending expiration date (EXP). It also serves to remind the agency that the record will have to be modified if the EXP is changed by the court.
2. If no action is taken by the entering agency to modify the EXP, the record will expire after the fifth day. Inactive records (cleared or expired) will be maintained on-line for the remainder of the year plus 5 years. At the end of that time, NCIC will not notify the ORI of record. Records that are in inactive status cannot be modified or cleared; however, inactive records can be canceled.

NCIC RETENTION PERIOD

3. Nonexpiring Records: Records for protection orders that have no expiration are referred to as nonexpiring records (NONEXP). These records will remain active until cleared or canceled by the entering agency.
4. Inactive Records: Inactive records (expired or cleared) will be accessible, via the QPO message, for the remainder of the year in which the record was cleared or expired plus 5 years.

JRA EXPIRATION

Please keep in mind...

- If you mark the defendant as present, it will mark the JRA expired as of that date
- If the Judge wants the JRA to remain until the next court date, you will change the expiration date in UCJIS to keep that JRA from expiring after 30 days. You will also NOT mark the defendant as present
- You can also go into the Jail Release Agreement screen in CORIS, enter OTN or name to search, select Expire.

HOW DO WE KNOW WHEN TO CANCEL A JRA OR PO?

- before you close out an active case, verify if there is a JRA or PO
- if neither one no longer exists, go ahead and close the case
- if a booking/arresting agency if a PO exists alongside your JRA, you may cancel your JRA since that PO has been issued
- courts when you issue a PO- you will need to cancel the JRA



DISSEMINATION OF INFORMATION ON A PO/JRA

- A copy of the PO can be requested from the courts
- You cannot disseminate PO or JRA information from UCJIS
 - Exception: you are disseminating to an authorized agency for an authorized purpose

DISSEMINATION OF INFORMATION ON A PO/JRA

- The only copy of a PO that you can give to anyone outside of an authorized ORI is the COURT ORDER PDF

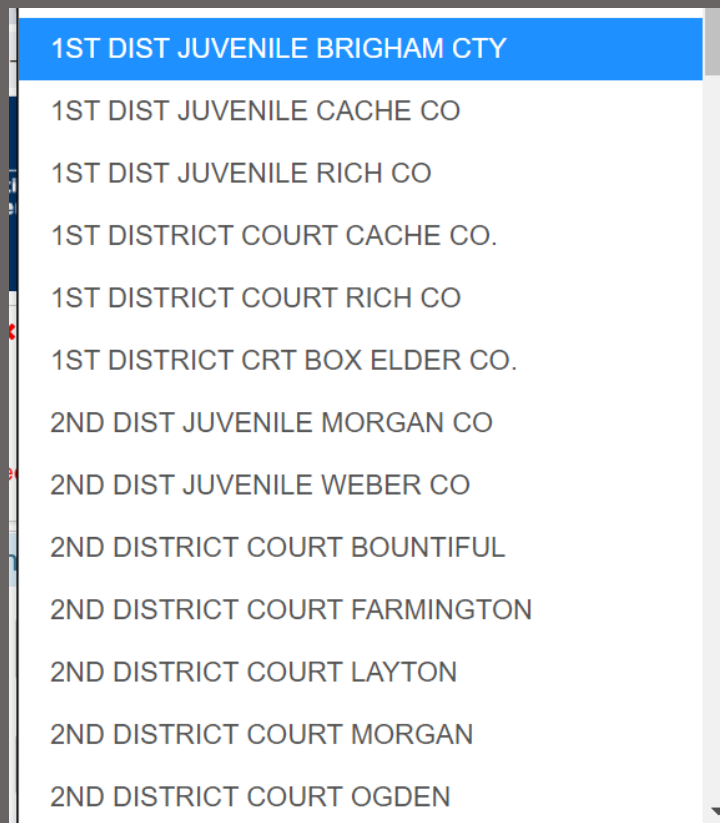

 - ❑ If you don't, the wrong court information will be listed on the JRA



I CAN'T PRINT A JRA WITH THE SIGNATURE LINES

- ❑ If you don't print the JRA from the tab that pops up after submitting a JRA, you will not be able to print one with the releasing officer and offender signature lines
