eWarrants

Overview

- ▶ **Available 24/7**
 - ▶ **Allows law enforcement to electronically submit warrant requests to prosecutor and magistrate**
 - ▶ **Allows magistrate to electronically retrieve and review warrant**
- 

eWarrants Process

- ▶ **Officer selects warrant type and inserts information into fields in EWEL transaction**
- ▶ **UCJIS creates affidavit using the selected template and provided information**
- ▶ **Affidavit available to print or download**
- ▶ **Officer electronically submits affidavit to magistrate**
- ▶ **Magistrate electronically approves or denies warrant**
- ▶ **Can be approved or denied in minutes**

eWarrants

Background

- ▶ **2007: Officer performs blood draw on DUI suspect without warrant after fatal accident. Cites “exigent circumstances”**
- ▶ **Blood test reveals that suspect’s blood alcohol content was well above legal limit**
- ▶ **Suspect is convicted of Automobile Homicide**

eWarrants

Background

- ▶ Appeals court overturns conviction citing precedence from a 1966 Supreme Court ruling
- ▶ Utah Supreme Court reverses decision and affirms conviction
- ▶ Utah Supreme Court urges lawmakers to utilize modern technology to make warrant requests and approvals available more quickly

CURRENT STATUS

- ▶ Judges have been trained and equipped
- ▶ Judges in on-call rotation
- ▶ Several warrant templates available

 - ▶ E-mail address on file with BCI
 - ▶ Access to the eWarrant transactions
EWEL (submit) and EWQL (query)
 - ▶ Remove pop-up blocker on web browser
