- 24 hours to hold suspect

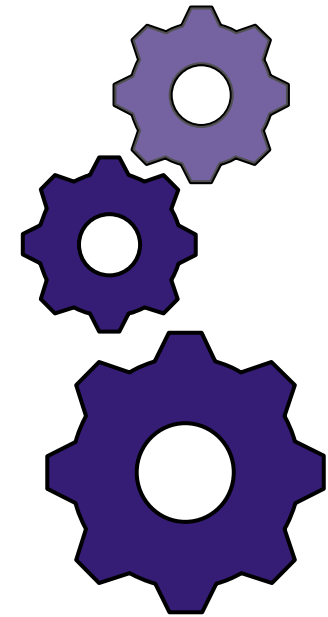

Troubleshooting Common PC Errors

What do I do if I send the PC to the wrong jail?

Have the jail send it back to you then you will have to start all over and select the correct jail.



Troubleshooting Common PC Errors

What do I do with a PC that I made an error on and no longer need?

Delete the old PC by pulling it up through the PCQ transaction and selecting “Delete Affidavit”

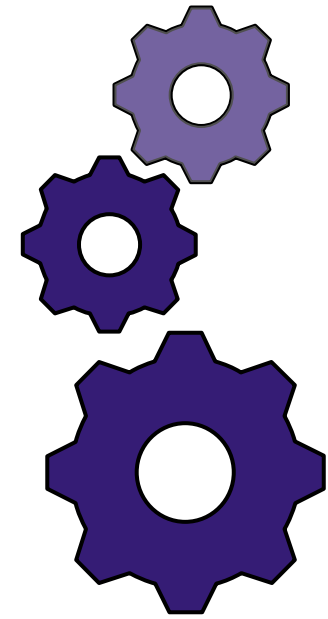

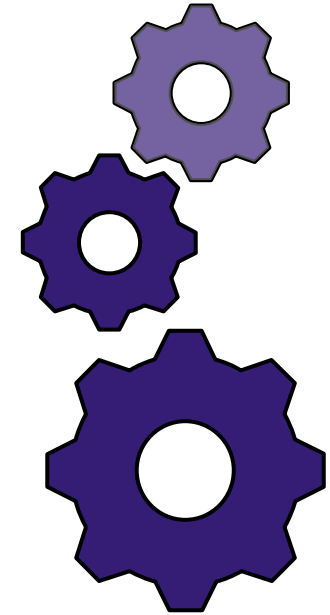

Troubleshooting Common PC Errors

What do I do if the status of the PC says
“Will submit to court as soon as possible”?

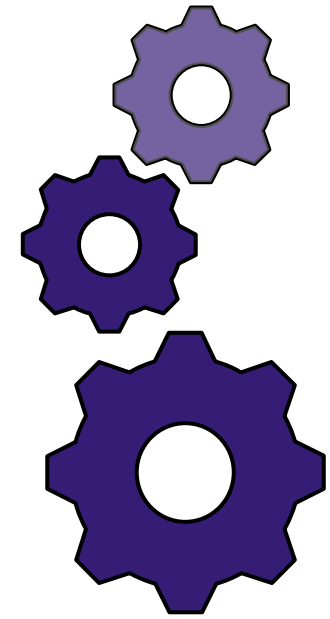
This just means that it has not connected to the court yet. Once it connects, the status will change to “Submitted to court”. If it stays in this status for longer than 30 minutes, contact the Help Desk.



Troubleshooting Common PC Errors

What do I do if I entered the wrong charges, deleted them, entered the correct charges and the wrong charges still appear on the PDF?

Copy and paste the information you entered on the PC into a word document and start over with a new PC entry

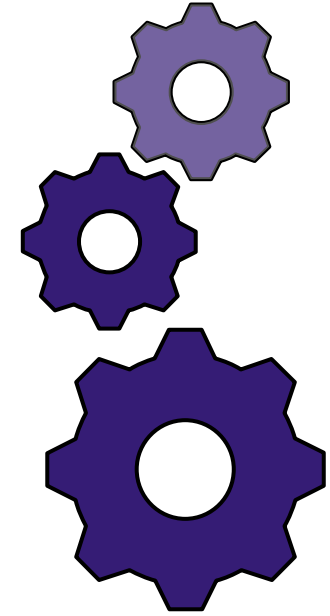

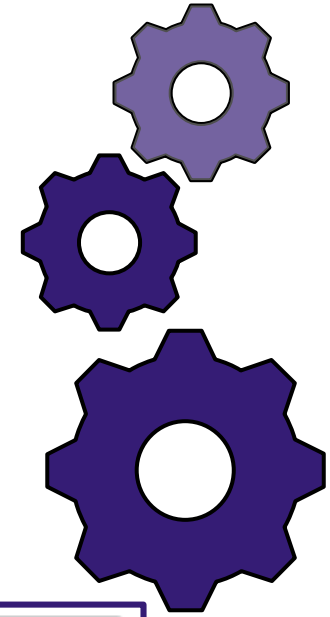
What options do I have to fix a PC I submitted, if I enter the wrong badge number?

If it has been submitted already to the jail, have the jail send it back so you can fix it and resubmit.

If it is already submitted to the judge then the incorrect badge number cannot be modified on the submitted PC.
