What is a JRA?

 Jail Release Agreement: or a temporary Protective Order
 O Created by an arresting agency upon citation of the respondent

OR

• Created by the jail upon the releasing of the respondent

How are they created?

- Issuing agency utilizes the ENCO transaction in UCJIS
 - Be sure you fill out all the required fields as 0 well as anything additional that you can
 - Allows the JRA to be pushed onto NCIC

Booking Facility: ENCO

How long are JRA's valid?

- JRA's are automatically set to expire 30 days after issuance
- Only the court can extend the expiration date

**** If the respondent violates a JRA, they can be arrested and charged

Who can modify a Booking facility- if the individual was booked Arresting agency- if they created the JRA or if the booking agency that created the JRA listed the arresting agency on the JRA

How are they modified?

Arresting/Booking agency: MNCO
Courts: MCJR



What can be modified?

Arresting/Booking:

- Conditions
- Cancel JRA

Courts:

- Conditions
- Expiration date
- Court of next appearance

Modify Conditions


(Check Condition to Remove) Having been arrested for Domestic Violence, I agree to the following conditions prior to my release on bail, recognizance or otherwise:

□ 1. I will have no personal contact with the alleged victim

2. I will not threaten or harass the alleged victim

3.1 will not knowingly enter onto the premises of the alleged victim's residence or any premises temporarily occupied by the alleged victim

To modify- uncheck the conditions to be changed and then hit submit button

Court System

- If you mark the defendant as present, it will mark the JRA expired as of that date
- If the Judge wants the JRA to remain until the next court date, you will change the expiration date in UCJIS to keep that JRA from expiring after 30 days. You will also NOT mark the defendant as present
 You can also go into the Jail Release Agreement screen in CORIS, enter OTN or name to search, select
- Expire

Protective Orders

What is a Protective Order?

- An order from the court
- Can place restrictions on the respondent if the court finds the respondent committed violence (or threatened violence or attempted violence) against the petitioner

- A protective order can order the respondent to:
 - Not commit violence against people listed on the order
 - Not contact or communicate in any way with people listed on the order
 - Stay away from the petitioner's home, work, school, or place of worship
 - Comply with restrictions at the respondent's work, school, and place of worship
 - Not possess, have, or buy a firearm or other type of weapon
 **** If the respondent violates a protective order they can be

How is one issued?

- Petitioner fills out required forms and files them with the court
- Court reviews the request
- Petitioner and respondent go to court
- Court can issue or deny the request

Who Do I Contact?

- Can't remember the transaction
- Need access to ENCO, MNCO or MCJR
- Receive error messages running the ENCO, MNCO or MCJR transaction

- Correct court is listed but the court contact info is incorrect
- Incorrect court is selected; they will be able to modify the JRA

FAQ's and Common Questions:

If you have more than 1 protected person and they are waiving their rights differently: • You will need a JRA for each person You will use one OTN linked to the booking and grab another one of your agency's assigned OTN's and utilize that for the second party

FAQ's and Common Questions

• A copy of the PO can be requested from the court of issuance
