Recent Changes to Legislation

HB392

- During the 2022 Legislative session HB392 a pilot bill was passed to wave certificate fees and court filing fees. This bill suspended those fees from May 4,2022 - June 30, 2023.
- When HB392 was passed this extended the "10 year rule" to not include Misdemeanor B convictions or any drug convictions.
- This bill also changed how BCI receives orders from the courts to being through a digital portal. (Petitioners can still drop off or email there orders to BCI.)
- BCI now sends a broadcast message to all agencies involved in the case to remove incidents from their records.

HB323

 HB323 was presented in the 2023 session to extend the expungement fee waivers from May 3, 2023 - June 30, 2028 but failed to pass.

HB431

 HB431 was passed during the 2019 legislative session. This was due to go into effect in 2020 but due to COVID and programming Auto/Clean Slate did not start until April of 2022.





Petitioned Expungements

Utah Code §77-40a



Traffic and Minor Regulatory Offenses for Petitioned Expungements

Traffic offenses as defined in §77-40a-101(15)(a)

Most traffic offenses can be expunged without limit as long as time periods have been met and have no pending cases or fines owed.

Traffic charges are not included in determining if a person is eligible for future certificates of eligibility and expungement. A petitioner can petition the courts for their traffic offenses §77-40a-305(3)

When expunging a traffic offense the record will only be deleted from court records and will not affect the Utah State Drivers License files.

Minor Regulatory offenses as defined in §77-40a-101(12)(b) and(c)

"Minor regulatory offense" includes an offense under Section 76-9-701 or 76-10-105

Minor Regulatory charges are not included in determining if a person is eligible for future certificates of eligibility and expungement. But BCI will offer certificates for these cases if they are eligible.

Certificateless Cannabis Convictions

§77-40a-305(4)

A petitioner may file a petition for expungement of a record for a conviction related to cannabis possession without a certificate of eligibility if the petitioner demonstrates that:

- (a) the petitioner had, at the time of the relevant arrest or citation leading to the conviction, a qualifying condition, as that term is defined in Section 26B-4-201; and
- (b) the possession of cannabis in question was in a form and an amount to medicinally treat the qualifying condition described in Subsection (4)(a)

Once these Orders are signed they are sent through our portal to BCI and we process those orders with no certificates to match to.

Reasons for Denial for Petitioned Expungements (Cont.)

Non Drug Offenses

- There is a criminal protective order or a criminal stalking injunction in effect for the case §77-40a-303(2)(f)
- Fines, interest, and restitution not paid §77-40a-303(1)(a) and (b)
- Time required by law not met §77-40a-303(1)(c)
- Two or more felony criminal episodes §77-40a-303 (4)(a)
- Any combination of three or more convictions that contain two class A misdemeanors §77-40a-303(4)(b)
- Any combination of four or more convictions that contain three or more class B misdemeanors §77-40a-303(4)(c)
- Five or more misdemeanors or felony episodes §77-40a-303(4)(d)

Time limits required by law for Petitioned Expungements

- 10 years Any alcohol/drug related DUI/reckless driving offense
- 7 years Eligible felonies
- 5 years Class A misdemeanor
- 4 years Class B misdemeanor
- 3 years Class C misdemeanor and infractions
- 30 days Dismissed with prejudice
- 180 days Dismissed without prejudice

3 or more felony possession convictions. §77-40a-303(5)(a)

5 or more possession convictions §77-40-303(5)(b)

Time periods for Drug Possession Offenses:

5 years - Class A misdemeanor or felony

4 years - Class B misdemeanor

3 years - Class C misdemeanor and infractions

30 days - Dismissed with prejudice

180 days - Dismissed without prejudice

What does BCI require to start an application?

- Applicants must fill out
 - Name
 - Previously used names (if applicable)
 - Date of birth
 - Mailing address
 - Drivers license state and #
 - Social Security # (optional)
 - Email address (only if they want everything through email only)
- Applicants must print, sign and date the middle section
- Fingerprints are required and the "Official Taking Prints" section must be completely filled out.
- Non refundable \$65 fee must be paid either by cash (in person only), Check, Money Order, or Credit Card.
- If anything is missing the application will be rejected and sent back to the applicant or corresponding 3rd party.

What does BCI require on the "3rd Party Release From"

- Name of person BCI is allowed to talk with
- Agency (if applicable)
- Mailing address of the 3rd party
- Email (if the 3rd party wants to receive all documents through email)
- Name of applicant
- Signed and dated by applicant

BCI only allows 2 people as a contact for 3rd party releases. It is the applicants or the 3rd party responsibilities to notify BCI if they need to be removed or changed.

Petitioned Expungement Start to Finish

Step 1 Apply for a certificate of eligibility through BCI

- Expungement application forms can be found at: https://bci.utah.gov/expungement-forms-and-applications/, or can be requested in person at BCI
- BCI will conduct research to determine which incident(s) are eligible for expungement.
- BCI will send a Letter indicating which incident(s), If any, are eligible for expungement to the applicant or their 3rd party
- Indicate which eligible incident(s) you want to purchase, and pay all associated fees as indicated in the BCI letter. A certificate will need to be purchased for each eligible incident.
- Then the petitioner will take this list to the court that is listed for that case and give them the certificate number with the petition
- The applicant or 3rd Party will have 180 days to file those certificates and petitions with the courts. (Courts have there own additional fees)

Petitioned Expungement Start to Finish (cont.)

Step 2 File the petition with the court and serve the Prosecutor

- File a cover sheet, "Petition to Expunge," and "Order on Petition to Expunge" with the appropriate court
- Find forms and detailed instructions online at: <u>utcourts.gov/exp</u> or use the QR code below
- Call the Utah State Courts' Self-Help Center at 888-683-0009 if they need help with petitions or any court forms

Petitioned Expungement Start to Finish (cont.)

Step 3 - Respond to any possible objections and attend any court hearings.

- The prosecutor or victim in the case could object
- A petitioner can file a "Reply to Victim's or Prosecutor's Statement" find this form at utcourts.gov/exp
- If the court schedules a hearing, be sure to attend
- If the court grants your request, your records will be expunged with the courts

Petitioned Expungement Start to Finish (cont.)

Step 4 Distribution of Expungement Order(s) to Complete Expungement

- Once the court has expunged that case, the court will send BCI an electronic "Order to Expunge."
- BCI will notify all available agencies listed on the case of the expungement. The
 petitioners are still able to send a copy of the "Order to Expunge" to the agencies listed
 as well as BCI.
- BCI will expunge that case from the Utah Criminal History database and notify the FBI (if applicable) to expunge their record(s).
- A letter will be sent to the petitioner or 3rd Party via mail indicating removal of BCI records and notification to the FBI to remove their records.

WE ASK THAT THE PETITIONERS KEEP A CERTIFIED COPY OF EXPUNGEMENT ORDER(S) FOR THEIR PERSONAL RECORDS

EX Notification to Agencies

- Once BCI has deleted/finalized a case there is a broadcast message sent through UCJIS as an EX message.
- You can find these messages through the BMSG transaction.
- All information that BCI was able to find for the case will be provided in that broadcast message. If BCI did not have information available it will list as "not provided."
- You can view these messages for 21 days but should be viewed daily.
- If it has been longer than 21 days reach out to your Field Services representative on help to retrieve those messages.

****Per BCI attorney: "There is nothing in the expungement code that talks about physical evidence or property. Such items are governed under Title 77 Chapter 11C of the Utah Code. Agencies would be able to dispose of the property but must be in compliance with that code. It is best for them to talk with their attorney about the disposition of the property."****

Board of Pardons

- Applicants who are not able to expunge convictions through BCI due to having too many convictions or convictions that are not eligible to be expunged through statute (77-40a) still have a chance to go through a pardon.
 - To start the pardon process you must reach out to the Utah Board of Pardons (801) 261-6464
- If an applicant is granted a pardon the applicant will have to fill out a Board of Pardons Application
 with BCI and provide BCI with a copy of the pardon orders.
- There is a \$65 nonrefundable application fee.
- Once the application and orders are submitted, BCI conducts research into that application.
- Once research is completed we remove all pardoned incidents from the Utah Criminal History.
- Once the incidents have been removed BCI notifies all applicable agencies to remove those incidents from their files.
- BCI also sends the applicant or the 3rd party a letter stating what has been removed and BCI has notified the FBI (if applicable)
- Applicants or 3rd parties are still able to send copies of there orders to the applicable agencies involved.

Utah Code §77-40a-201 through 77-40a-203



AUTO EXPUNGEMENTS

Per Utah Code <u>77-40a-201</u> through <u>77-40a-203</u>, a certificate of eligibility is not required for Auto/Clean Slate expungement. These expungements are initiated and completed via an automatic process in place between the Courts and BCI. There is no application process for Auto/Clean Slate-eligible expungement.

Due to the volume of orders BCI is receiving, BCI cannot specify a specific date on which the charge(s) will be removed.

AUTO/CLEAN SLATE ELIGIBILITY

What is an Auto Expungement case?

- Dismissed with prejudice §77-40a-201(1)(ii)
- Acquittals§77-40a-201(1)(i)
- A "Clean Slate" Eligible case §77-40a-201(1)(iii)

Traffic Auto Expungements

- Records for the following traffic offenses shall be deleted without a court order or notice to the prosecuting agency
 - A traffic offense case that resulted in an acquittal on all charges §77-40a-202(1)(a)
 - A traffic offense case that is dismissed with prejudice, except for a case that is dismissed with prejudice as a result of successful completion of a plea in abeyance agreement §77-40a-202(1)(b)
 - Time periods have been met. At least 5 years for a Class C misdemeanor and at least 6 years for a Class B misdemeanor.
- Traffic Automatic Expungements are not sent to BCI

What is an Clean Slate Expungement case?

- A misdemeanor conviction for possession of a controlled substance in violation of Subsection 58-37-8(2)(a)(i)
- A class B or class C misdemeanor conviction or an Infraction that involves an individual whose total number of convictions in Utah state courts, not including infractions, traffic offenses, or minor regulatory offenses, does not exceed the limits described in Subsections 77-40a-303(4) and (5).
- A case dismissed as a result of a successful completion of a plea in abeyance agreement governed by Subsection 77-2a-3(2)(b)
- No criminal proceedings are pending in the state
- Time periods have been met
 - 5 Years for a Class C misdemeanor
 - 6 Years for a Class B misdemeanor
 - 7 Years for a Class A misdemeanor (Only for a conviction for possession of a controlled substance)
 - If a case is connected to another case by Transfer, Bound Over, Refile, Set Aside and etc. it will not be removed from Utah Criminal History.

AE Notification to Agencies

- Once BCI has deleted a case there is a broadcast message sent through UCJIS as an AE message.
- You can find these messages through the BMSG transaction.
- All information that BCI was able to find for the case will be provided in that broadcast message. If BCI did not have information available it will list as "not provided."
- You can view these messages for 21 days but should be viewed daily.
- If it has been longer than 21 days reach out to your Field Services representative on help to retrieve those messages.
- Agencies have 1 year from the date they receive the BMSG AE broadcast message to remove those records from there files.

What are BCI's Hiccups With Auto/Clean Slate Orders

Why Does BCI have manually touch so many of the orders?

BCI touches these because information the courts are sending to BCI are not matching our Criminal History. Mostly OTNs or SIDs are not matching or being sent over. Sometimes our names don't match. Or BCI never received fingerprints for those cases (meaning not on Utah Criminal History system)

BCI is still receiving convicted DUI orders even after we reached out in November of 2022 to fix the programing.

"EV" (Expungement Verification) Application



What Is An "EV" Application?

- When someone wants to know what they have had Petitioned AND Auto Expunged they can apply with this application
- What is included?
 - The applicant will receive 2 letters 1 for Auto Expunged information and 1 for Petition Expunged information.
 - The Auto Expungement letter if there are Auto Expungements for that person will include charges, Date of Violation, OTN, Court Case #, Agency Case#, Judgement Code, DOA, and arresting ORI if that information is available
 - If there are no Auto Expungements for that person or aliases they will receive a letter indicating there is no information found as of date.
 - If the applicant does have Automatic Expungements they will receive a copy of the order from the court.

What Is An "EV" Application? (cont.)

- The Petitioned Expungement letter if there have been Petitioned Expungements for that person will include Charges, Court Case #, Judgement Code, and DOA if that information is available
- If there are no Petitioned Expungements for that person or aliases they will receive a letter indicating there is no information found as of date.
- If the applicant does have previous Petitioned Expungements they will receive a copy of the order from the court and the corresponding certificate.

What does BCI require to start an application?

- Applicants must fill out
 - Name
 - Previously used names (if applicable)
 - Date of birth
 - Mailing address
 - Drivers license state and #
 - Social Security # (optional)
 - Email address (only if they want everything through email only)
- Applicants must print, sign and date the middle section
- Non refundable \$15 fee must be paid either by cash (in person only), Check, Money Order, or Credit Card.
- A photocopy of valid ID must be provided with the application
- If anything is missing the application will be rejected and sent back to the applicant or corresponding 3rd party.

What does BCI require to start an application?

 July 2024 The Sex Offender registry is moving to BCI. §77-41

What does BCI look at for early removal

- The application starts with BCI (\$230 application fee) - BCI will forward the information to The Department of Corrections to look further into there registration requirements.
- Once BCI receives the letter from the department of corrections we look into the probation time, make sure the offender has not been convicted of any other crimes since the incident they were required to register for, and make sure the charge is eligible.
- Once the final decision has been made by BCI the offender or 3rd party will receive 2 letters. 1 from the Department of Corrections and 1 from BCI
- If the offender is eligible for removal they will need to pay the \$25 certificate fee and file that certificate with the court within the 90 days. (courts have there own filing fees)
