# eWarrants

## Overview

- Available 24/7
  - Allows law enforcement to electronically submit warrant requests to prosecutor and magistrate
- Allows magistrate to electronically retrieve and review warrants



# eWarrant Background

- In 2007 an officer performed a blood draw on a DUI suspect
  - The officer did not have a warrant citing 'exigent circumstances'
  - According to the blood test, the suspect's blood alcohol content was well above the legal limit
- Suspect is convicted of Automobile Homicide




# eWarrant Background

- Appeals court overturns the conviction citing precedence from a 1966 Supreme Court Ruling
- Utah Supreme Court reverses the decision and affirms the conviction
- Utah Supreme Court urges lawmakers to utilize modern technology to make warrant requests and approvals available more quickly




# eWarrant Process

- Officer selects the warrant type and inserts information into the appropriate fields in the EWEL transaction
- UCJIS takes the entered information and creates an affidavit
- Affidavit becomes available to print and/or download



# eWarrant Process

- Officer can now electronically submit the affidavit to the magistrate
- The magistrate then electronically approves or denies the warrant
- This approval or denial process can take place in minutes no matter the time of day



# eWarrants

## Currently –

- Judges must be trained and equipped
- Judges are on an on-call rotation
- Various warrant templates available

Rule 40(c)(2) of the Utah Rules of Criminal Procedure states 'If the item sought to be seized is evidence of illegal conduct, and is in the possession of a person or entity for which there is insufficient probable cause shown to the magistrate to believe that such person or entity is a party to the alleged illegal conduct, no search warrant shall issue except upon a finding by a magistrate that the evidence sought to be seized cannot be obtained by subpoena, or that such evidence would be concealed, destroyed, damaged, or altered if sought by subpoena. If such a finding is made and a search warrant issued, the magistrate shall direct upon the warrant such conditions that reasonably afford protection of the following interests of the person or entity in possession of such evidence:

(c)(2)(A) protection against unreasonable interference with normal business;

(c)(2)(B) protection against the loss or disclosure of protected confidential sources of information; or

(c)(2)(C) protection against prior or direct restraints on constitutionally protected rights.'

In short, if you are seeking something like bank records you may need to obtain them through a subpoena unless one of the listed exceptions exists. 


# Electronic Service Provider

- ESP warrants stay on the system longer than other warrants. IF a ROS is not completed, the officer will continue to receive emails for the ESP eWarrant.
- If you no longer need the warrant, and the ROS has not been completed, you will have to contact BCI.
- BCI will have to manually remove the ESP eWarrant.

# DOPL Search Warrant


# Alcohol Restricted Driver

- Some web browsers do have spell check

# Things to keep in mind

- eWarrants purge from the system after 20 days or the day after the ROS has been completed if it's been on the system for more than 20 days. Unless you do the never purge option
- If an eWarrant is purged, you will need to contact the court that issued it
- Do not enter information in a field unless you want it to appear that way on the affidavit

# ESP eWarrant

Law requires that law enforcement and companies inform people when their information was accessed. So, if an officer does an ESP warrant on someone's Facebook information and the case is ongoing, they don't want the person to know. That way they don't delete stuff or change what they are doing. What should the officer do?



# ESP eWarrant

The officer would want to do a Delayed Notification – Law Enforcement template in UCJIS, so they wouldn't have to notify the person for 90 days. Then they could do the Delayed Notification – ESP template and that makes it so the company can't notify the person that their information was accessed for 90 days. They are both mainly used with the ESP template but can be used for all the warrant templates.
