


Fee Changes from BCI



<u>Fee changes for Applicant Background</u> Check System (non criminal justice)

Background check fees by type	
Name/DOB Utah Search	\$20 (+5)
WIN Only	\$20 (+5)
WIN/FBI Fingerprint	\$32 (+5)
WIN/FBI Vol Fingerprint	\$30 (+5)
WIN/FBI RapBack Fingerprint	\$42 (+10)
WIN/FBI RapBack Vol Fingerprint	\$40 (+10)
BCI Fingerprinting services	\$20 (+5)

These will take effect on July 1st, 2025.

Fee changes for Support Services

ROA	\$20 (+5)
Record Challenge	\$20 (+5)

These will both take effect on July 1st, 2025.

AMBER Alert



BCI performed a statewide test of the Utah AMBER Alert system on April 3, 2025. We appreciate those who assisted in this test and are happy to report it was successful in integrating the AMBER alert system to a more modernized platform. It is critical that law enforcement and the public understand the importance of an AMBER Alert, a key part being the criteria that is required to be met for the issuance of an AMBER Alert. In order to qualify as an AMBER Alert, the following FOUR criteria must ALL be met:

- 1. Law Enforcement believes it is a child abduction?
 - Forcibly taken against their will, or by means of deception.
 - Taken by a NON-Custodial parent (NOT a custody dispute resource)
- 2. 17 years of age or younger?
- 3. Imminent danger, serious bodily injury or death?
- 4. Information to assist the public in the safe recovery of the victim or apprehension of the suspect?
 - Victim(s)/Suspect name, description, license plate etc.

Upcoming BCI Training

BCI Field Services is excited to provide important training to all criminal justice agencies in May. These trainings are geared towards all UCJIS users and we would like to invite you to share this information with your agencies and register your users to attend.

Upcoming UCJIS Baseline Training:

BCI Field Services will be teaching a Virtual UCJIS Entry Training class on **Thursday May 15, 2025** and a Virtual NCIC Inquiry
Training class on **Wednesday May 21, 2025**.

The NCIC Entry training will cover how to "enter" into NCIC using UCJIS. Transactions include Utah Alerts such as AMBER, Missing Persons, Articles, Guns, Wanted Persons, Vehicles, and Images. This training class is open to all UCJIS users who would like training on how to enter data into NCIC using the UCJIS system. This training will begin at 8:00 AM and go until approximately 5:00 PM.

The UCJIS Inquiry training will cover how to "inquire" into UCJIS. UCJIS transactions that will be covered include DLQ, UCH, III, NCIC, QSW, MIL, and more. The training class is open to all UCJIS users who would like training on how to inquire into the different files available in the UCJIS system. The training will begin at 8:00 AM and go until approximately 4:00 PM.
